General Information

- Students ages 13-18 are eligible to participate in the Page and Messenger Program.
- Pages and Messengers may receive service hours credit for their week of participation.

PAGES

- Work in the House Chamber assisting Representatives
- Working hours vary day-to-day based on the session schedule

MESSENGERS

- Work in the Capitol and surrounding buildings of the Capitol Complex
- Work hours are 8 a.m. to 5 p.m., Monday through Friday

Orientation

Pages and Messengers are required to attend orientation the Monday morning of their week of participation. At orientation, a complete schedule for the week and expectations for the week will be discussed. Families are encouraged to attend orientation and any of the optional tours and activities.

As time allows, Pages and Messengers may participate in optional tours and educational activities. This may include a mock legislative session, attend a committee meeting, tour of the Governor's Mansion, the Florida Supreme Court, the Museum of Florida History, and the Historic Capitol.

Transportation, Lodging, and Food

Pages and Messengers are responsible for their own transportation to Tallahassee and the Capitol each day. They are also responsible for their own lodging and meals.

Once assignments are made, all applicants will receive notification by email. Applicants accepted into the program will receive a guidebook with the required forms to complete.
